European Cooperative Programme for Plant Genetic Resources (ECPGR) Phase X (2019–2023)



Financial situation by the end of 2023

Contributions received for Phase X (Table 1)

As of 31 December 2023, the total regular contributions received for Phase X amounted to €2,648,150. Outstanding contributions for Phase X amounted to €38,750 from three countries.

Voluntary contributions were received during 2023 from Germany (€246,714), as payments earmarked to the EVA Network and the project for the inclusion of *in situ* crop wild relatives (CWR) data in EURISCO. An additional €10,000 were received from the European Regional Focal Point for Animal Genetic Resources (ERFP), as a contribution to the *Genetic Resources* journal.

Phase X Budget (Table 2)

The starting budget for Phase X (€2,688,250) was agreed at the 15th Steering Committee meeting in Thessaloniki, Greece (May 2018). It was subject to an overhead of 15.84%, as per the agreement with Bioversity International. This amount was reduced in 2021 to €2,672,500, due to the removal of Bosnia and Herzegovina from the participating countries and of its originally expected 5-year contribution of €15,750 from the budget. This reduction has been reflected through a corresponding reduction of the budget line 'Secretary staff costs', which is underspent, for the years 2022 and 2023. The total budget has however been incremented in the past five years by: 1) Unspent carry-over from past phases (net €121,756), with overhead 13%; 2) Carry-over from Phase IX totalling €186,570 with overhead 18.15% (net €157,909); this budget line was used in 2022 to create a budget line of €28,896 for donations to the Ukrainian genebank, for which Bioversity International waived the overheads. Therefore, the budget line 'Carry-over from Phase IX' was reduced to €157.674 (net €133.452): 3) Voluntary contribution from Hungary for Phase X (€12,000, net €10,359); 4) Pledged voluntary contributions from Germany to be used during Phase X reaching a total of €1,421,876 with an increase in 2023 by €51,549 for the EVA project. The amount of German contributions is partly made of funds already advanced in Phase IX, funds actually received in 2019-2021 and other funds pledged for the rest of Phase X and for the year 2024, as part of a series of projects funded by Germany and listed in Table 2; 5) Annual contribution (€14,400) for 2023 from Poland, which joined ECPGR during this year; 6) Contribution in 2023 (€10,000) from ERFP to the Genetic Resources journal.

After the above-mentioned increments and decrements, the overall budget for Phase X was set at €4,454,930.

Expenditures (Table 2)

At the end of 2023, the total expenditures were €3,459,895, leaving an overall balance of €916,132 after five years of Phase X. This under-expenditure was accumulated during the years partly due to lower staff costs, thanks to the contributions from the EU-funded Horizon projects AGENT, GenRes Bridge and Pro-Grace and the projects funded by Germany¹. Low expenditures for travel and Working Group activities were due to the late start of the Grant Scheme Calls and the intervening COVID-19 pandemic, which reduced the possibility of travelling and holding physical meetings in 2020 and 2021. In addition, fewer applications were received for Grant Scheme Activities and fewer were granted in Phase X, compared to Phase IX. Expenditures were consequently below expectations during Phase X. Other savings were made due to lower expenditures charged to ECPGR by the EURISCO coordination at IPK. In the last two years 2022 and 2023, expenditures increased both for staff costs (for the first time four full-time staff persons working at the Secretariat, covered in part by the above-mentioned EU- and German-funded projects) and due to restarting Grant Scheme activities and Working Group meetings (these activities were mainly charged to the 'Carry over from past Phases' budget lines, leaving almost untouched the Working Group activities budget lines of Phase X).

Significant expenditures were made as part of the German projects on the EVA Network and for the more recent project dedicated to the *in situ* CWR data into EURISCO.

¹ In 2023, ECPGR staff costs were partially covered by the EU projects AGENT (€47,467) and Pro-Grace (€64,636) and by the German-funded projects EVA (€48,000) and *in situ* CWR in EURISCO (€13,277), for a total of €173,380.



Six activities approved through the Grant Scheme (6th Call) have started in late 2023 and the corresponding expenditures will largely be made during Phase XI. Therefore, part of the balance that is being carried over to Phase XI is already committed (net estimate €211,654).

Detailed expenditures from carry-over funds (Table 3)

Most of the expenditures related to Grant Scheme activities of both Phase IX and X were charged to the 'Carry-over' budget lines, as detailed in Table 3. With these funds, it was also possible to cover some inevitable costs at the Secretariat, including extraordinary website maintenance, which is no longer covered by the host institute, but also other costs related to publications (the *Plant Genetic Resources Strategy for Europe*), communication (roll-up posters), shipments and other smaller miscellaneous costs.

Outstanding contributions from past Phases (Table 4)

Table 4 shows outstanding contributions of past Phases from a few countries that signed the Agreement to join ECPGR in the respective Phases and benefited from the Programme as members, but never completed the agreed payments. These contributions have been removed from the ECPGR budget and thus they are no longer awaited. However, should these countries decide to rejoin ECPGR, the Steering Committee may wish to consider whether these past dues should be entirely or partially waived before re-admitting the country to ECPGR. During 2023, the outstanding contributions of Azerbaijan (€13,750) and Ukraine (€28,000) have been waived by the Steering Committee, to facilitate these countries rejoining ECPGR during Phase XI.

Conclusion

The funds balance of Phase X (as of 31 December 2023) amounts to €787,325 (regular ECPGR funds) + €7,350 ('Genetic Resources journal' funds) = €794,675 (£686,011 net of 15.84% overheads). This is the result of unspent funds in several budget lines, as explained above. These funds will be carried over to Phase XI.

In addition, unspent funds from the German grants (€88,187) will be carried over and used to complete the specific grants commitments and tasks.

An estimated calculation of the funds that were unspent at the end of 2023, but already committed for ongoing activities related to Phase X, as outlined above, is totalling €211,654. Therefore, €686,011 - €211,654 = €474,357 (net of overheads). This is an estimate of the carry-over funds that can be allocated to match a large part of the missing funds of the Phase XI budget.

The cash balance at the end of 2023 was positive, amounting to €882,862.

- In 2022, the total budget was further increased by EUR 98,464 representing an amendment to the voluntary contribution from Germany for "Implementation of EVA network on wheat, barley, vegetable crops and maize GenR 2019-2".
- In 2023, the total budget was further increased by EUR 24,400 representing regular contribution from Poland (EUR 14,400) in 2023 and EUR 10,000 representing contribution from ERFP for "Genetic Resources"
